Motion: Limit Shares While Driving

- Presenter: Chris C.
- Summary: Request for members to pull over or turn off video while driving to model safe behavior and avoid potential accidents
 - Safety concerns and professionalism
 - •Concern it imposes outside rules inconsistent with AA Traditions

Motion did not pass substantial majority after re-vote and does not carry

First Vote:

- Y = 20%
- N = 67%
- AB = 13%

Second Vote:

- Y = 37%
- N = 63%
- AB = 0%

Motion: Implement Ban for Disruptive Behavior

- Presenter: **Peaches**
- Summary: Establish a one-year ban from all 319 meetings for members engaging in severe disruptive or threatening conduct (including predatory, harassing, or anonymity-breaking behavior). Members may petition Safety & Support for reconsideration after one year.
 - Protecting member safety and meeting integrity; addressing repeated violations.
 - Concerns about vagueness, lack of due process, and possible overreach.

Motion did not carry

First Vote:

- Y = 77%
- N = 21%
- AB = 3%
- Hugh asked the Chair to Stop making up the Rules

Second Vote:

- Y = 65%
- N = 32%
- AB = 3%
- Implementation: Details deferred to next session ("Part Two")
- Debbie raised concerns about DM-based harassment by members currently on hiatus.
- Chair clarified the distinction between hiatus (temporary behavioral hold) and ban (removal)
- Tim (Safety & Security) scheduled a Safety & Support Sharing Session for Wednesday, October 15, 6:30–7:30 p.m.

Motion: Time Limit on Shares

• Summary: Proposal to reduce individual share time from 4 minutes to 3:30.

Motion withdrawn before discussion. No vote recorded

Meeting Adjourn: 9:02pm
